CORRECTABLE VIOLATIONS:

Those driver's license, vehicle registration, and mechanical violations cited in accordance with Vehicle Code section 40610a will be dismissed by the court if PROOF OF CORRECTION is presented to the court by mail or to person, on or before the appearance date.
